NOTIFICATION

In view of the directions of the **Honorable Supreme Court in SLP No. 24295 of 2006 dated 16-05-2007** and in Civil Appeal number 887 of 2009, dated 08-05-2009, to prohibit, prevent and eliminate the scourge of ragging, in exercise of the powers conferred under Section 23 read with Section 10 (b), (g), (p) and (g) of AICTE Act, 1987, the All India Council for Technical Education has notified Regulations for prevention and prohibition of ragging in AICTE approved Technical Institutions vide No. 37-3/ Legal/ AICTE/ 2009 dated **01.07.2009 and Maharashtra Prohibition of Ragging Act, 1999.**


